- The function sendReward() uses the loop to iterate through \_rewardedAccounts and \_enteringAccounts lists. Function will be aborted with OUT\_OF\_GAS exception if there will be a long addresses lists.
- The function emergencyUnlock() also uses the loop to iterate through \_enteringAccounts and \_rewardedAccounts lists. It also could be aborted with OUT\_OF\_GAS exception if there will be a long addresses list.

#### Recommendation:

Check that the arrays' length is not too big.
